

**MEMORANDUM OF UNDERSTANDING BETWEEN
NATIONAL PRODUCTIVITY COUNCIL (NPC) AND EdCIL (India) Limited (EdCIL)
(FOR COLLABORATION IN DEVELOPING PRODUCTIVITY MODULE FOR SCHOOLS
AND VOCATIONAL INSTITUTES)**

This agreement made on this 18th day of JANUARY 2017 at NEW DELHI between

NATIONAL PRODUCTIVITY COUNCIL hereinafter referred to as NPC having its registered Office at Utpadakta Bhawan, 5-6 Institutional Area, Lodhi Road New Delhi, represented by the Director General, (which expression unless it be repugnant to, or excluded by the context or meaning thereof be deemed to mean and include its successors, assignees) first part.

And

EdCIL India Limited, hereinafter referred to as EdCIL, having its registered office at 5th Floor, Vijay Building, 35 - Barakhamba Road, New Delhi and corporate office at EdCIL House, 18-A, Sector 16-A, NOIDA- 201301 represented by the Chairman and Managing Director (which expression shall unless it be repugnant to, or excluded by the context or meaning thereof be deemed to mean and include its successors, assignees) second part

Whereas,

1. PURPOSE

The aim of this MoU is primarily to establish a written document under which both the organizations may enter into a written agreement to perform collaborative programmes in the areas of mutual interest. This MoU may be followed by specific agreement/contract outlined in statement of work (SoW) for each project taken by the parties, outlining mutual responsibilities subsequent to this undertaking.

2. AREAS OF COLLABORATION

- Joint efforts for promotion of productivity knowledge in educational sector including primary to higher education and vocational to technical education.
- Conducting training programmes / workshops for productivity promotion on agreed terms and conditions





- NPC and EdCIL can mutually get associated for projects related to productivity promotion in educational sector especially through IT applications and using gaming techniques
- Exchange of faculty / resource person(s) between the two organizations

3. AGREEMENT FOR COLLABORATION

Each such collaboration undertaken by the two organizations shall describe in detail the following:

- a. The nature, scope and time of collaborative schedule
- b. Financial implications
- c. Any other provision as deemed to be necessary and agreed by both

4. NODAL AUTHORITY

The nodal officer from NPC shall be Director General, NPC or any nominee and the Nodal officer from EdCIL shall be Chairman and Managing Director or any nominee for all the decision making and concurrence

5. IMPLEMENTATION AND ACTION PLAN

- a. NPC and EdCIL shall endeavor to finalize the details of implementation and action plan of collaborative efforts to execute the parts of this MoU
- b. The MoU shall be effective from the date of signing and same shall remain in effect for 5 years and may be renewed or discontinued thereafter by mutual consent, giving notice of 30 days by either side.
- c. Financial commitments related to joint activities will be decided mutually by both organizations

6. DISPUTE RESOLUTION & CONFIDENTIALITY

Any dispute to be resolved amicably by the executants of the MoU, otherwise, the dispute to be referred to an 'Arbitrator' under the Arbitration and Conciliation Act, 1996 to be appointed with the consent of both the parties. The decision of the 'Arbitrator' will be final and binding on both the parties. At the same time, utmost confidentiality to be maintained by both the parties during the validity of MoU.



7. FORCE MAJEURE

Neither party shall be made responsible for an unexpected or uncontrollable event.

The parties herein have agreed and signed this document on this 18th day of JANUARY 2017 as under as per above clauses.




