**Problem Definition:**To assess the production and productivity of Inland fisheries from different sources, to assess the reasons for wide variation in production and productivity of Inland fisheries in different sources, to collect information about innovative technologies used by progressive fishers and fish farmers in the country, to find out the extent of contamination and pollution of Inland water fish sources by arsenic and other heavy metallic matters, fly ash, sewer and drainage water and other sources.

### Few Recommendations Made:

- i. The electricity charges being high renders semi-intensive and intensive aquaculture practices unviable. Aquaculture should be treated on par with agriculture for the purpose.
- ii. It is suggested that Clean and Hygienic fish market with refrigeration facilities may be set up by the State Governments. This will reduce the post harvest losses and the consumers will get better quality of fishes.
- iii. It is suggested that hatcheries may be set up, both in Government sector and private sector so that farmers may purchase seeds from these hatcheries. Moreover, the prices of seeds of fishes particularly cold water fisheries and saline water fisheries are on higher side. Therefore, these seeds should be available on reasonable price.
- iv. It is suggested that fish feed mill, both in Government and private sectors may be set up in fish producing areas.
- v. Regular training and awareness programs may be organised by the State Governments for fish farmers.etc.
