Non-Utilization of GST Input Tax Credit (ITC): Until FY 2021-22, NPC was not availing GST Input Tax Credit (ITC), leading to financial losses.

GST Demand Notice: NPC received a GST Demand Notice (No: GST-15/ADJ/DE/NPC/22/2019-20/235) regarding Service Tax applicability on plan funds received from the government.

Show Cause Notice (SCN): NPC was issued a Show Cause Notice (SCN Reference No. ZD0709230527924 dated 26-09-2023) for FY 2017-18, with a tax demand of ₹14,36,590/-.

Recommendations Made:

Implemented new accounting procedures to enable GST ITC claims, allowing NPC to avail ₹68 lakhs in FY 2022-23 and continue benefiting in FY 2023-24 & in coming future years.

Personally attended the GST Demand Notice hearing, submitted a structured response, coordinated with the GST department, and successfully closed the demand in favor of NPC.

Drafted a detailed response to the Show Cause Notice (SCN), leading to the entire demand being dropped without any financial liability to NPC.
