#### **TIMELINE:**

This survey to be completed within a 3-month timeframe after award of work. Please attach your work plan to complete the work in 03 months.

### **PAYMENT Terms & Conditions:**

- 1. Advance: An initial payment of 25% of the total project value will be made upon signing of contract agreement. This serves as a commitment and initiation fee.
- 2. Milestone Payments: Two additional payments will be made based on successful completion of pre-defined milestones:
  - i) 25%: This payment will be released upon satisfactory completion of field survey, as outlined in the project scope and timeline.
  - ii) 50%: The balance and final payment of 50% will be done on acceptance of field survey data in excel form covering stakeholders as defined under scope of work mentioned above.
- 3. Payments will be made through RTGS / NEFT. Bidders should provide their bank details duly signed by authorized signatories along with the copy of cancelled cheque.
- 4. TDS will be deducted as per Prevailing Rules.

#### **Eligibility Criteria:**

- 1. The survey agency must be a registered company/agency with valid GST and PAN nos.
- 2. The survey agency must have an average annual turnover of Rs. 5 crore for the past 3 years.

- 3. The survey agency must have experience of conducting at least 3 pan-India surveys in rural areas for Government organizations, each work order having worth Rs. 15 lakhs or more, covering at least 10 Indian states.
- 4. The survey agency should have presence in above mentioned 8 sample states.
- 5. The survey agency should have minimum 50 employees conducting surveys.
