- The applicant(s) Consulting Companies / Energy Audit Firms are required to pay a registration fees of Rs 500/- (inclusive of applicable taxes) towards the registration with NPC.

Payment Terms & Conditions:

- Registration fees has to paid through the E- Payment Gateway mentioned at NPC website (www. npcindia.gov.in)
- The registration of the Individual certified Energy Auditors/ Energy Audit Firms shall be confirmed only after receipt of the one-time non-refundable registration fees.
- The Registration fees once paid will not be refunded under any circumstances for the registration energy auditors/ energy audit firms.
