- Content has to be provided in Bilingual (English & Hindi), Audio / Video and/or Text format (PDF / HTML / MS- word / MS-PowerPoint etc.) or any other format as may be required.
- ➤ The Audio / Video content can be a mix of animations, PPTS with voice over or lecture by an expert, white board etc subject to the approval of NPC.
- Case study based approach in each module.
- Explanation of concepts using simple language with suitable graphics/images and relevant examples in each module.
- Assessments may also be provided at the end of the each module/ session with complete answers and explanations.
- Assessments need to be prepared in the form of MCQs with complete answers and explanations for different topics/concepts within chapters.
- Question Bank needs to be prepared for each module/ session.
- ➤ Questions in the form of MCQs/True or false with complete answers and explanations for different topics/concepts within each module.
- Questions should be both subjective and numerical type.
- Foot notes and hints should be available wherever necessary.

- ➤ Each module should contain summary with major takeaways.
- Coordinating and assisting to Integrate and update contents in NPC's Learning Management System.
- > All the content developed/updated must be approved by NPC before finalization.
- ➤ The content should be highly interactive and engaging.

- > The Applicant must be an individual/ agency/ company/ firm registered in India.
- The Applicant should neither have been blacklisted and/or debarred by any Central/State Govt. Departments/PSUs/ Educational Institutions/Organization etc.
- ➤ The Applicant should have experience in conducting online training or elearning module preparation of more than three (03) years in related areas in Govt. Depts. / Educational Institutions / PSUs & Pvt. Sector etc.
