## **REGISTRATION FEES:**

- I. The applicant(s) Individual Consultants are required to pay a registration fees of Rs 5,000/- (inclusive of applicable taxes) towards the empanelment with NPC.
- II. The applicant(s) Consulting Companies / institution are required to pay a registration fees of Rs 25,000/- (inclusive of applicable taxes) towards the empanelment with NPC.
- III. The applicant(s) Academic Institutions are required to pay a registration fees of Rs 100,000/- (inclusive of applicable taxes) towards the empanelment with NPC.
