2	Providing and fixing of new wooden partition attached with 2"x 1.5" wooden frame and 6 mm ply board both side with one wooden door and complete fittings in 140 sq ft.	
3	Installation of iron frame jaal with 40x40x5 mm angle iron frame with 1.5 strips welding size 5.5x3	
4	Providing and fixing of new wall tiles with repair & plaster with material and labour for 30 sq ft area.	
5	UPVC window fixed glass removing and new window installing.
