



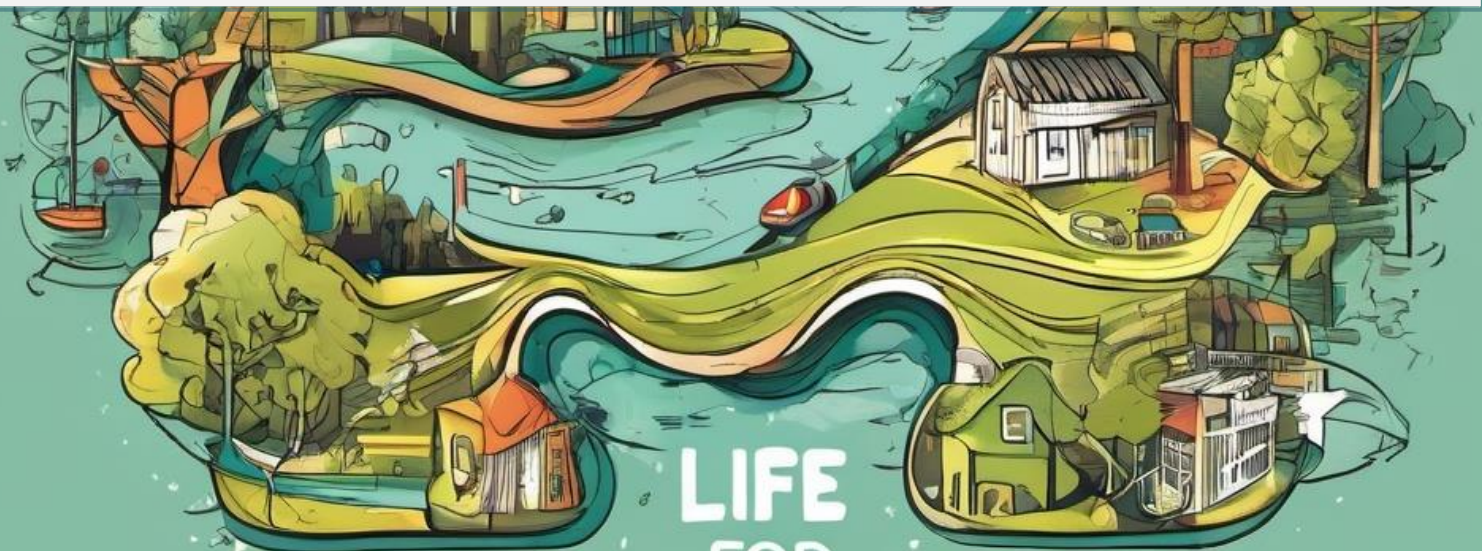

1. ABOUT NPC

National Productivity Council (NPC) is an autonomous organization under the Department of Promotion of Industry and Internal Trade, Ministry of commerce & Industry, Government of India. The program fosters sustainable habits through a step-by-step approach, encouraging participants to make one positive change daily, transforming their lifestyle over time. A key feature of the training program is the Green Credit Programme, which incentivizes environmental actions by various stakeholders through a market-based approach. Participants learn how to generate and trade Green Credits, awarded for actions like waste reduction, energy conservation, and sustainable agriculture, motivating both individuals and the private sector. Community engagement is emphasized, fostering a collective sense of responsibility and encouraging community-led initiatives to amplify the impact of individual actions. The Pro Planet People (P3) model underpins the program, promoting a lifestyle in harmony with the planet by advocating mindful and deliberate utilization of resources. The expected outcomes of the program include a significant reduction in carbon emissions, increased environmental awareness, enhanced community resilience, and the widespread adoption of sustainable practices. By educating, empowering, and engaging participants, Mission LiFE aims to create a global movement towards sustainable living, addressing environmental challenges, and building a more resilient and sustainable future for all.

3. LEARNING OBJECTIVES

This training program aims to sensitize participants in the following ways:

1. Encouraging organizations to adopt simple yet impactful environmentally friendly practices.
2. Facilitating rapid responses from industries and markets to meet changing demands.
3. Promoting policies towards Net Zero sustainable consumption and production.
