In addition, just having a law does not help. Many times, women question whether a particular behaviour can be counted as sexual harassment even after they felt uncomfortable or violated. So, it is important for employees to know what is acceptable in the workplace, what constitutes to sexual harassment and what does not.

 receive POSH training, it not only helps them to fight against sexual harassment but also helps
 them avoid being charged.

- This training program will help participants to be aware of what to do if their colleagues are subjected to sexual harassment. This training program is designed for both employees and management, regardless of their gender or designation.
