These rules and orders are treated as an executive instruction that need to be observed by all Departments and Organisations under the Government and specified Bodies except otherwise provided for in these Rules"- as noted in the preface of the GFR 2017 Rule. To make the administrative personnel aware and competitive about the new changes by the Government, a five-day capacity building programme has developed to improve productivity.
