Hence, the purpose of this program is to sensitize participants on the aspects of Sustainability and Business Responsibility and Sustainability Reporting (BRSR).

Environmental issues may include corporate Climate Policies, Energy Use, Waste Management, Pollution Prevention and Control, Natural Resource Conservation etc. ESG considerations can also help evaluate any environmental risks a company might face and how the company is managing those risks. Considerations may include direct and indirect Greenhouse Gas Emissions, management of toxic waste, and compliance with environmental regulations.

For measuring, monitoring and disclosing performance in areas related to ESG, the Securities and Exchange Board of India (SEBI) has mandated the sustainability disclosure requirements. Under this BRSR shall be applicable to the top 1000 listed entities (by Market Capitalization) from FY 2022-23.
