#### 1. ABOUT NPC

Micro data analysis permits the policy makers, business analysts, research scholars to answer complex questions and provide valuable insights for drawing inferences and decision making.

This program aims to introduce participants to the fundamental practice of analysing micro-data using SPSS (Statistical Package for the Social Sciences), a statistical software widely used by social scientists, researchers, and business analysts. SPSS helps users efficiently manage and analyse critical micro-data through simple and quick steps. Participants will learn how to perform basic statistical analysis, enhancing their ability to process and interpret data effectively for research or business purposes.

#### 3. LEARNING OBJECTIVES

This training programme will enrich the participant's ability to:

- Store Micro-data (available in any international standard formats like SPSS, XLS, ASCII, STATA, RDBMS data like MS ACCESS etc) using SPSS
- Organise the stored data (including Dictionary attaching, Transformation, Aggregation, Merging, Sorting etc)
- Generate Output in Custom tables
- Represent the Tabulated Output in suitable graphical formats
- Perform requisite Descriptive Statistics of interests (e.g. mean, median, mode, sd, correlation coefficient etc) & their interpretation
- Perform frequently used basic inferential statistical test & analysis (including t-test, chi-square test, regression analysis etc)
- Export the output / results in various international formats (e.g, XLs, PDF, MS-Word etc.)
- Export the final or intermediate SPSS data into various international standard formats (e.g. ASCII, XLs, RDBMS like MS-ACCESS etc.)
- Work with NSSO like critical micro-data using SPSS Menu driven system and/or using SPSS Syntax (without having programming knowledge / skill / experience) easily successfully.

- Reading / storing Micro-data available in international standard formats
- Attachment of Micro-data dictionary (including Variable Labels / Value Labels etc)

- Generation of Cross-tables / Custom-tables in prescribed formats
- Generation of Basic statistics for making Statistical hypothesis testing / interpretation / inference
- Graphical representation of Data for quick & clear understanding the underlying fact
- Aggregation of Micro-Data
- Merging of related Micro-data (cases / variables)
- Generation of NSSO like Official Statistics /Tables as in Published reports
- Project on Micro-data Processing & Statistical Analysis using SPSS
- Queries and Answers

#### 5. METHODOLOGY

The programme shall be participative in nature. The training shall consist of detailed demonstration on using the SPSS for analysis of the micro-data. Every demonstration shall require to be self-performed by the participants on the published micro data set, therefore **it is advised to bring your laptop with SPSS installed**.
