1. ABOUT NPC

Hence a huge sum of public fund is utilized towards such procurement. In order to contain corruption and promote transparency, e-procurement system has been mandated in all Government Departments and Public Sector Units, which paves the way for unbiased decision making by providing equal opportunity to all bidders. At the same time the Department/ Organization can obtain value for the money spent in a just manner.

The programme throws light on the concept of E- Procurement and procedure and also on the role of Preventive Vigilance in every Organization, which in other words, is the basis for Key to Good Governance.
