An occupational health and safety management system (OHSMS) is a framework that allows an organization to consistently identify and control its health and safety risks, reduce the potential for incidents, help achieve compliance with health and safety legislation and continually improve its performance.

Health and safety at work not only save lives, they are essential to effective business performance. ISO 45001:2018 is the first and only International Standard for occupational health and safety (OH&S) management, a result of agreed good practice from around the world.

Following are the benefits of implementing ISO 45001:2018 occupational health and safety (OH&S) management system:

- Prevent work-related incidents
- Improve legislative compliance
- Improves hazard identification and risk assessment.
