Conceived by Government of India, GeM is an e-business platform for procurement of goods & services by government organizations. GeM offers all modes of procurement (direct purchase, L1, bid & reverse auction) in a paperless manner. The GeM portal is currently being used by almost all departments/ organizations of central and state governments as mandated mandatory by the Government of India.

Objectives

- The programme aims to enhance efficiency & accountability of organisation through “Effective Procurement Management”.
- To enhance competency level of the participants on the subject public procurement, e-procurement & GeM

Target Audience:
