About the Program

Access to sufficient amounts of safe and nutritious food is key to sustaining life and promoting good health. Unsafe food containing harmful bacteria, viruses, parasites or chemical substances, causes more than 200 diseases –ranging from diarrhoea to cancers. WHO reports that an estimated 600 million –almost I in 10 people in the world –fall ill after eating contaminated food and 420 000 die every year, resulting in the loss of 33 million healthy life years (DALYs -Disability Adjusted Life Year -One DALY is the equivalent of one lost year of healthy life, combining the burden due to sickness and death. Measuring health impact in DALYs allows comparisons between dissimilar diseases and aids in prioritization)

Program Objective

Food safety, nutrition and food security are inextricably linked. Unsafe food creates a vicious cycle of disease and malnutrition, particularly affecting infants, young children, elderly and the sick. Unhygienic and unsafe food handling practices leads to numerous food borne diseases and affects the consumers. Also pose a risk to socio-economic development agenda of the Government. In the present context of global pandemic, it is now even more important to understand the food safety requirements and Essentials. This program aims at Introducing the Concepts of Food Safety and Essentials which is very important for Food Business operators/ Food Handlers.
