ISO 14001:2015 standard can be used by any organization that wants to improve resource efficiency, reduce waste, and drive down costs. Compliance to ISO 14001:2015 standard can provide assurance to management and employees as well as external stakeholders of an organisation that environmental impact is being measured and improved.

The benefits of implementing an Environment Management System as per ISO 14001:2015 standard are:

- Cost savings in waste, recycling and consumption
- Management of environmental risks
- Compliance with environmental regulations
- Demonstrates your commitment to improving the environment
- Shows you are a responsible future focused organisation
- Advantage over competitors when tendering for business
- Can reduce insurance cover costs
- Can increase employee engagement in the knowledge that they are working in an environmentally friendly organisation

There are two phrases that indicate what kind of document is required by ISO 14001:2015 standard. The phrase "retain documented information as evidence of ..." means the record needs to be produced, while the phrase "maintain as documented information" means that the document needs to be developed, including the procedures.

Generally following four types of manuals are prepared to comply with the requirements of ISO 14001:2015 Standards:

- Apex Manual,
- Procedure Manual,
- Work Instruction Manuals and
- Work Instruction Manuals
