- **Prevent work-related incidents**

**Generally following four types of manuals are prepared to comply with the requirements of ISO 45001:2018 Standards:**

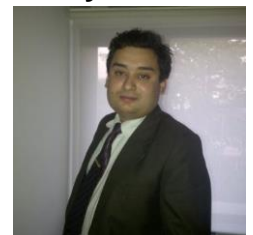
- **Apex Manual,**

- **Work Instruction Manuals**
