Food Safety and Standards Authority of India (FSSAI) is a statutory body under Food Safety and Standards Act, 2006. The Food Safety and Standards (FSS) Act, 2006 is the primary law for the regulation of food products. This act also sets up the formulation and enforcement of food safety standards in India.

Food on sale for human consumption must be wholesome, unadulterated, uncontaminated, properly labelled and fit for human consumption. Violation of the provisions in these regards may lead to regulatory action against the concerned FBO under the Act, or rules and regulations made there under.

Food recalls are an appropriate method for removing or correcting marketed food products and their labelling that violate the laws administered by the regulatory authority. Recall can be defined as an action to remove food products from market at any stage of the food chain, including that possessed by consumer, which may pose a threat to the public health or food that violate the Act, or the rules or regulations made there under. Recall of food product is in the common interest of the industry, the government and in particular the consumer. Manufacturers and/or distributors should initiate a recall at any time to fulfill their responsibility to protect the public health from products that present a risk of injury or gross deception, or are otherwise defective. Firms may also initiate a recall following notification of a problem by Food Authority or a state agency, in response to a formal request by authority, or as ordered by Authority

Complaints are a fact of life for any food business. They are practically unavoidable. A food process, like any other process, experiences variation and other failures which can lead to complaints. A robust Complaint Management system helps in effectively handling the customer complaints and recalls.
